BYLAWS OF THE HORSHAM MOTOR SPORTS CLUB INCORPORATED - Updated: 9.8.2009

CLUB MEETING will be advertised in the local paper, or notice will be given in the Club Newsletter or by electronic format CLUB MEETINGS are governed by the H.M.S.C Inc. Model Rules; the bylaws are accepted by members.

- 1. All persons on the executive should be full financial members of the HMSC Inc. All persons acting, as officials on race day must be full financial members of a speedway-affiliated body recognised by HMSC Inc or life members of HMSC Inc.
- 2. All membership monies are to be paid to the Membership Secretary.
- 3. The Committee has the right to call for any member to produce a current medical certificate, if they feel there is any reason to doubt his/her fitness for competition or as a race official.
- 4. THERE IS TO BE NO PRIVATE PRACTISE AT THE TRACK!
- 5. Any person found quilty of an offence not arising out of competition shall be dealt with by the Committee
- No member may enter into any arrangement incurring liability on the Association without having the item put to the vote at Committee level.
- 7. An order number from the order book or the name of the purchaser is to be used for all club purchases. If the committee does not agree with a purchase, the purchaser shall be personally responsible for payment.
- 8. That any of the four office bearers of the Committee are ex-officio members of any sub-committee formed by the Association.
- Race Committee to consist of the President, Secretary, Treasurer, Chief Scrutineer and Steward, Pit Marshall, Assistant Secretary, Race Secretary and Publicity
 Officer, with the power to co-opt other members.
- 10. Race Secretary to handle all class negotiations and class formats. The committee must then approve all class negotiations.
- 11. The numbers 4 to 99, with the numbers 20, 30, 40, 50, 60, 70, 80, and 90 are to be deleted will be available for member's cars, keeping in mind, that there is to be no duplication of numbers within the club of the Association.
- 12. Any sub-committee formed, must bring all suggestions for approval at Committee level, prior to any action being taken.
- 13. Any member resigning, or leaving the Association for any reason, whatsoever, shall return all Association property, when requested to do so, by any member of the executive.
- 14. Any delegates attending meetings on behalf of the HMSC may claim traveling expenses of up to 45¢/km each way.
- 15. All Club cars to be in pits and scrutineered at least two hours prior to advertised race time or will run rear of field until after interval. (Scrutineers to mark time of scrutineering in the logbook).
- 16. No UNOFFICIAL tow vehicle to be allowed on the infield during the race meeting.
- 17. New drivers to start REAR OF FIELD until cleared by the Chief Steward
- 18. Class must field a minimum of four cars for class racing, points and/or prize monies. Features must field a minimum of ten cars, unless an exception is made by the committee, prior to the race meeting commencing.
- 19. Handicapping or classing of cars to be handled by the Chief Steward in conjunction with the Pit Marshall. The Pit Marshall also has the power to co-opt 1 other person.
- 20. Abuse to tow truck drivers, Pit Marshall, Scruitineers, Water crew, Stewards or any other officials, will earn an immediate fine, and/or suspension to be issued by the Chief Steward or by the committee to be then approved by the Chief Steward.
- 21. Boundary gates to be kept locked.
- 22. Any driver entering the track property intending to compete without the appropriate SAFETY APPAREL will be fined a minimum of \$20.00 and be disqualified from that event.
- 23. No photographer allowed on the infield, unless approved by both the Chief Steward and the Pit Marshall.
- 24. We the Horsham Motor Sports Club Inc. reserve the right to accept or reject any driver's nomination.
- 25. If a driver change is not notified to the Pit Marshall, then that car and those drivers lose all points gained that day.
- 26. Any club car, not represented at working bees, and/or club meetings to the satisfaction of the Committee, may be excluded from the draw.
- 27. Licensed H.M.S.C.Inc. Drivers and registered H.M.S.C.Inc cars are the only one eligible for the H.M.S.C.Inc aggregate and awards.
- 28. NO uninsured persons to be in the pit area. Drivers are responsible for their crew's actions.
- 29. In exceptional circumstances, the Chief Steward has the option of adding two extra cars R.O.F. in a feature event. His decision is final on this subject.
- **30.** No person may enter the track proper during the racing or during a stoppage without gaining the permission of the Steward. A minimum fine of \$100.00 and immediate disqualification of the driver and car concerned will ensue, and may be fined up to a maximum of \$1000.00.
- 31. Committee to make all pre-race day cancellations. Cancellations on the day of racing are to be made by the race committee as per by-law 9.
- **32.** No tow money to be paid to any car.
- 33. Lady drivers may race in any class event, on any day, including both "Ladies" and "Open" events providing that the race vehicle nominated conforms to the class specifications.
- **34.** All speedway cars to be removed from the speedway grounds within two days of the completion of the race meeting, or a fine to be set by the Committee, may be incurred. All speedway vehicles to be removed from the speedway grounds within two days of the completion of the race meeting, or a fine to be set by the Committee may be incurred, unless a prior arrangement has been made.
- 35. No one under the age of 16 years is to drive, travel in or on an Association owned/operated vehicle on race day.
- **36.** All persons in the pit area are required to be attired in overalls or identifying crew or club uniform, consisting of a sleeved t-shirt, shorts below the knees, and enclosed shoes as per NASR rule. Officials to be dressed in a clean and tidy manner according to position, with some form of identification as to their name and position with the Club.
- 37. Main gates are to be closed and locked until the advertised time. Persons requiring entering the pits must show license or pit crew pass.
- **38.** Only fundraising authorized by the HMSC Inc. are to be sold on the speedway premises.
- **39.** Under no circumstances should any club member make a public statement to the media, or enter into any contract or commitment on behalf of the Club without first gaining the approval of the Executive Committee, the Club President or Club Secretary.
- 40. A committee member absent from three consecutive committee, race committee and/or general meetings, without leave of absence, shall automatically be removed from office.
- 41. Chief Scrutineers may charge a travel fee of 15 cents per km each way for any car that he/she is requested to travel to outside the city area. A fee of \$20.00 may be charged for dealing of engines.
- 42. All racing will cease by a specified time each race night, and no racing will be conducted after 12 midnight. Variations to this will be AS SPECIFIED BY THE COMMITTEE OF THE H.M.S.C.Inc.
- 43. All persons must nominate by Monday night 9.00pm, prior to race night, unless otherwise specified on the entry forms.
- 44. All vehicles must be suitably muffled and must not exceed the 95-decibel rating.
- 45. Drivers that sign in as Officials are required to pay admission on race day.
- **46.** No race meeting to start any later 6.30pm
